Problem

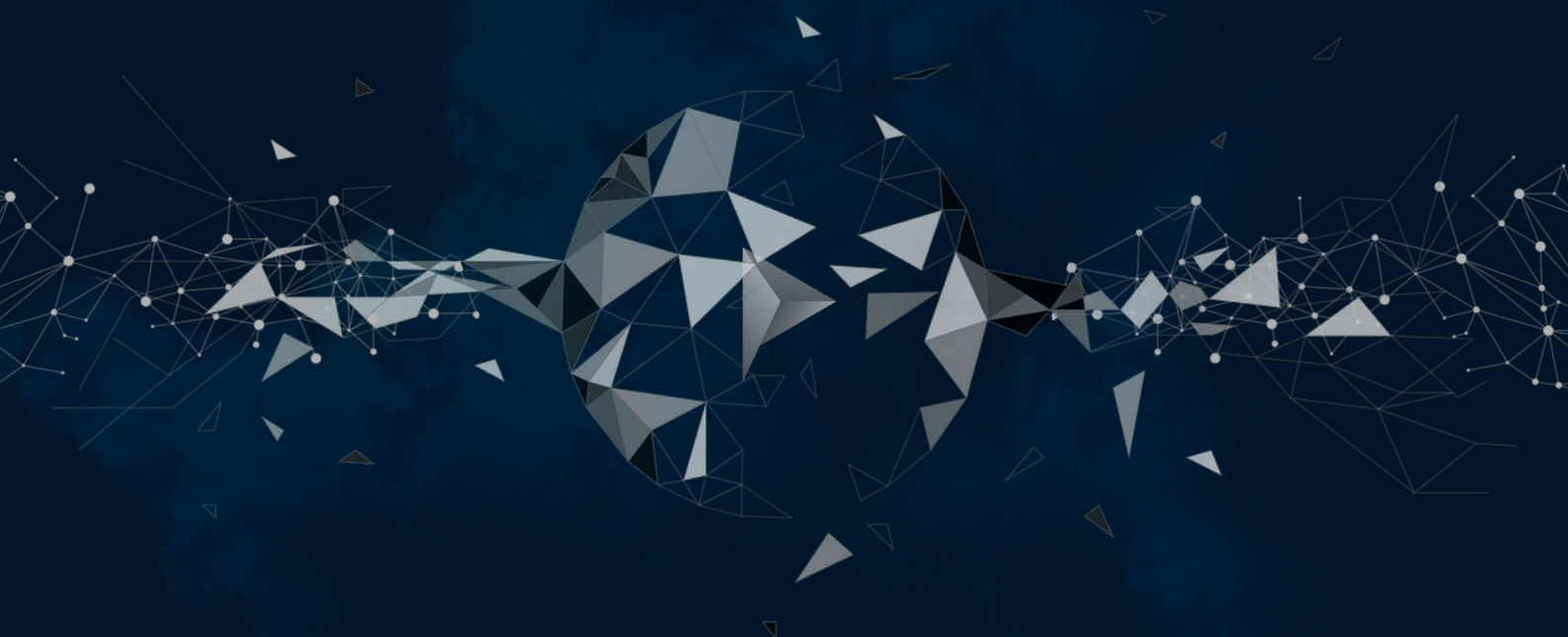

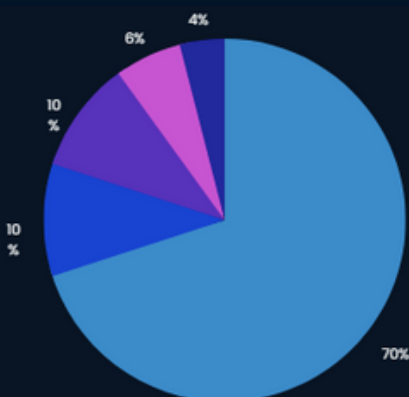

\$PNS Token's Utility

The \$PNS token serves a wide range of purposes as a utility token:

1. Holders with a minimum of 2000 \$PNS tokens gain access to discounts and offers with our merchant partners online and in-store.
2. Holders can use \$PNS token as a means of payment on our crypto payment gateway.
3. Businesses that decide to accept transactions in \$PNS, will be charged a 0.5% transaction fee.

As the platform continues to grow and new features are developed, we will implement additional use cases for the \$PNS token that will become available over time.



Team Allocation – The team includes founders, core team members, contractors, and consultants.

Marketing – Global events, influencers, social advertisement, and online press releases.

Research & Development

Token Taxes

For each executed transaction in which someone buys or sells \$PNS, a commission is charged according to the image shown to the right. The commission is divided into two parts, each with its own purpose. When buying \$PNS, the commission is 4% of the total transaction, and 6% of the total transaction when selling. Transactions between users have zero commission.
